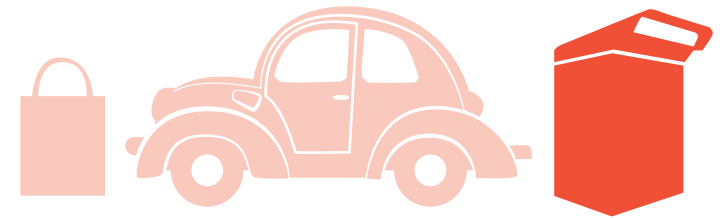

available; rest of building remains closed*



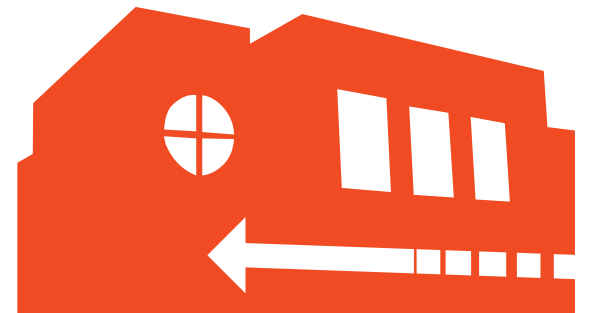

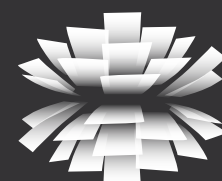
